PROGRAM GOAL AND BENEFITS:

GOAL: To train the targeted audience that provides comprehensive ambulatory care to HIV-infected patients, to stimulate continued professional growth through the utilization of secondary and tertiary referral/consultative resources and services, and to ultimately increase the number of primary care practitioners working with HIV-infected patients in Mississippi.

BENEFITS: This program is designed for the practitioners in private practice who anticipate seeing HIV-infected patients, or those who have begun seeing these patients and are in need of a more comprehensive knowledge base and enhanced clinical skills. It will also benefit those practitioners who have been seeing HIV-infected patients for awhile, but are in need of an informational and clinical update.

PROGRAM OBJECTIVES:

Upon the completion of this training the participant should be able to:

- discuss course fundamentals;
- identify the basic pathogenesis of HIV disease;
- demonstrate appropriate initial evaluation and medical treatment of HIV infected adults;
- describe the epidemiology of HIV in the United States and in Mississippi;
- determine appropriate antiretroviral interventions for the early symptomatic period of HIV disease;
- identify factors that affect adherence to antiretroviral regimens & possible methods to influence adherence;
- explain the process of the AIDS Drug Assistance Program (ADAP);
- discuss the association between HIV and STDs;
- compare and contrast STD presentation and treatment in HIV infected individuals and HIV negative individuals;
- describe opportunistic infections with appropriate pharmacological prophylaxis recommendations;
- demonstrate provision of sexual risk prevention counseling to HIV positive clientele;
- discuss challenges inherent in caring for women, children and adolescents with HIV disease;
- identify demographic picture of persons 50+ living with HIV;
- discuss case-based antiretroviral treatment strategies involved in HIV positive individuals;
- formalize a culturally sensitive approach when developing a patient care assessment and plan for the HIV positive client and their family;
- describe mental health disorders that commonly occur among people with HIV/AIDS;
- explain how mental health disorders can affect physical health, medication adherence, and risk for HIV transmission/re-infection;

- review the importance of screening and risk assessment in the prevention of negative outcomes among people living with HIV/AIDS and a comorbid mental health disorder;
- and discuss the program evaluation tools.
